Pursuant to Chapter 551, Title 5 of the Texas Government Code, the Texas Open Meetings Act, notice is hereby given that the **Youth Advisory Board**, of the City of Brownsville, Texas, in accordance with Article V, Section 12, of the Charter of said City, will convene a **Work Session on February 7, 2026 at 10:00 a.m.**, in the **Meeting and Break Room**, at the **Brownsville Animal Regulation Care Center**, located at **416 FM 511**, Brownsville, Cameron County, Texas, 78575.

Pursuant to Section 551.127, Texas Government Code, one or more Board Members or employees may attend this meeting remotely using videoconferencing technology. The video and audio feed of the videoconferencing equipment can be viewed and heard by the public at the address posted above as the location of the meeting.

The members of the Board and the public wishing to participate in the meeting must attend in person.

**Non-Agenda Items:** Kindly submit a “Public Comment Form” stating the City business or City Policy you wish to speak to an hour before the start of the scheduled meeting time with the City Secretary. Forms are not reserved for anyone nor may time be deferred to anyone. PowerPoint presentations may not be accommodated. This period is limited to five (5) speakers with a time limit of three (3) minutes per speaker.

**Agenda Items:** Kindly submit a “Public Comment Form” stating which item(s) on the agenda you wish to speak to an hour before the start of the scheduled meeting time with the City Secretary. Speakers will be allowed to address the Board on the agenda item before it is considered. The speaker is limited to three (3) minutes.

**Time Limits:** The Youth Advisory Board shall have the discretion to modify its regulations regarding time limits on public comment if necessary. For example, the time limit may be shortened to accommodate a lengthy agenda, or it could be lengthened to allow additional time for discussion on a complicated matter, or if there is need for an interpreter.
