Pursuant to Chapter 551, Title 5 of the Texas Government Code, the Texas Open Meetings Act, notice is hereby given that the Paseo De La Resaca Lighting and Landscaping of the City of Brownsville, Texas, in accordance with Article V, Section 12, of the Charter of said City, will convene a **Regular Meeting**, on **February 19, 2026**, at **5:15p.m.**, at the Brownsville Events Center, 1 Events Center Boulevard, Brownsville, Cameron County, Texas 78526

At any time during the course of the posted meeting, the Brownsville Board or Commission members may retire into Executive Session under Texas Government Code 551.071 to confer with legal counsel on any subject matter on this agenda in which the duty of the attorney to the Brownsville Board or Commission members under Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code. Further, at any time during this meeting, the Brownsville Board or Commission may retire to deliberate on any subject slated for discussion at this meeting, as may be permitted under one or more exceptions to the Texas Open Meetings Act set forth in Title 5, Subtitle A, Chapter 551, Subchapter D of the Texas Government Code.

PUBLIC COMMENT PERIOD

- **Non-Agenda Items:** Kindly submit a “Public Comment Form” stating the City business or City policy you wish to speak to an hour before the start of the scheduled meeting time with the City Secretary. Forms are not reserved for anyone nor may time be deferred to anyone. PowerPoint presentations may not be accommodated. This period is limited to five (5) speakers with a time limit of three (3) minutes per speaker.
- **Agenda Items:** Kindly submit a “Public Comment Form” stating which item(s) on the agenda you wish to speak to an hour before the start of the scheduled meeting time with the City Secretary. Speakers will be allowed to address the Board or Commission on the agenda item before it is to be considered. The speaker is limited to three (3) minutes.
- **Time Limits:** The Board or Commission shall have the discretion to modify its regulations regarding time limits on public comment if necessary. For example, the time limit may be shortened to accommodate a lengthy agenda or it could be lengthened to allow additional time for discussion on a complicated matter or if there is a need for an interpreter.

- 1) Report from consultant regarding PDLR public parkways and any required consideration and action on items or issues raised therein. (Steve Walker – Consultant)
- 2) Presentation, discussion and acknowledgment of the financial report. (Finance Services Department)
- 3) Presentation, consideration, discussion, and possible action to authorize the payment of claims and execution of checks related thereto. (Financial Services Department)
- 4) Presentation, consideration, discussion and possible action regarding the district’s amended investment and strategy statement policy. (Financial Services Department)
- 5) Report and discussion from the City Parks and Recreation Department (PARD) regarding the operation and maintenance of PDLR public parkways and resacas' lighted aerators, with consideration and action on same if warranted. (PARD)
- 6) Discussion and possible action regarding the circulation of a survey to PDLR residents to identify their preferred allocation of PID funds. Survey options may include, but are not limited to, replacement of playground equipment, improvement of areas lacking grass, installation of additional trees and benches, assistance with repairing fences adjacent to parks, repairs to irrigation systems and pipes, or, alternatively, a reduction in future PID assessments as soon as feasible.
- 7) Presentation, discussion, and possible action on implementing a drainage protocol to clarify responsibility for maintaining waterways within the PID during heavy rainfall and to ensure a coordinated flood response.
- 8) Presentation, Discussion, and possible action regarding the resumption of maintenance services to two resaca aerators located (1) between Emerald Cove and Emerald Valley, and (2) between Emerald Cove and Fox Hollow.
- 9) Presentation, discussion and possible action regarding the implementation of a designated percentage or amount of the budget for safety and beautification purchases at regular intervals.
- 10) Presentation, discussion and possible action regarding a pollinator garden behind Hudson elementary.
