Speakers will be allowed to address the Board on the agenda item before it is to be considered. The speaker is limited to three (3) minutes.

- **Time Limits:** The Board shall have the discretion to modify its regulations regarding time limits on public comment if necessary. For example, the time limit may be shortened to accommodate a lengthy agenda or it could be lengthened to allow additional time for discussion on a complicated matter or if there is a need for an interpreter.

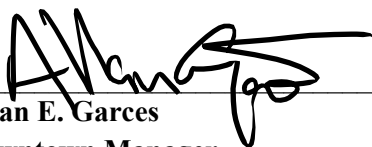
